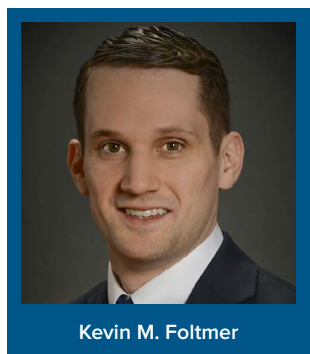




P&A Attorney Kevin Foltmer Appointed to the New Jersey Supreme Court's District IIB Ethics Committee
